Hereinafter jointly referred to as "**THE TRUSTEES**" (which expression shall unless excluded by or repugnant to the subject and context be deemed to include the Trustee or Trustees for the time being of the presents and/or survivor or Survivor of any of them and their successor or successors in office) of the **OTHER PART**.

**WHEREAS** the settlor is desirous of establishing in perpetuity a fund amounting Rs. 10,000/- in India for charitable purpose including relief to the poor, education, medical relief and advancement of any other object of general public utility. Not involving or carrying on of any activity for profit all over India and for this he is desirous of setting up a Public Charitable Trust for the advancement of the said object in India and whereas the Trustees as above, at the request of the settlor, have given their consent to act as the trustees along with the Settlor for administration of the affairs of the said Trust in accordance with the terms and the conditions hereafter provided.

**WHEREAS** The Settlor, hereby conveys, transfers, and assigns to the Trustees the above referred sum of Rs. 10,000/- (Ten Thousand Rupees) only as corpus to the Trust, the receipt of which, the Trustees do hereby admit and acknowledge, The Settlor of the **TRUST** hereby conveys, transfers assigns to the **TRUSTEES** the aforesaid funds as mention in the schedule hereunder of the Not any immovable and or movable properties as of now and allows the trustees to have and to hold the same in trust as corpus or the trust, to be used by the trustee to carry out and fulfill the objects of the trust set forth here win and the settlor of the trust hereby relinquishes for all time any claim to or interest in the said assets or fund forming the subjects matter of the trusts.

**NOW THIS INDENTURE WITNESSETH AS FOLLOWS: -**

1. Name of the trust shall be: **SREE SREE SIKDER PUKUR SMASHAN KALI MANDIR AND DURGAPUJA WELFARE TRUST.**
2. The Registered Head office of the Trust shall be located at Village & Post Office - Baradhemo, Police Station - Asansol (South), District - Paschim Bardhaman, PIN - 713359, West Bengal, India.
3. The office of the Trust may be opened to any other place in West Bengal or to any other state of India or open local office or offices at Places deemed necessary. **This place shall be used for corresponding address only and shall not be treated and used as Trust Property.** It may be noted that the above mentioned corresponding address is not the property of Government or any other Government Authority.

**4. INTERPRETATION:-**

Trust means the Trust created by this Deed viz, **SREE SREE SIKDER PUKUR SMASHAN KALI MANDIR AND DURGAPUJA WELFARE TRUST (A non profitable non commercial PUBLIC CHARITABLE PURPOSE ONLY)**

- a) The Board shall mean the Board of the members which may be filled up by co-option of the existing Trustees created by this Deed with renowned and suitable Family Members.
- b) **TRUST PROPERTY:-** shall include every kind of property movable and immovable to be owned by the Trust and mentioned in accounts, books and other documents in the possession, custody and control or that ought to be in possession, custody and control or possession of the Trust.

**5. AIMS AND OBJECTS OF TRUST:-**

That the aims & objectives of the trust shall be of general public welfare and other charitable purpose including relief of the poor, education, medical relief and advancement of any object of public utility not involving the carrying on of any activity for profits as defined under the income-tax act, 1961 and/or under any order for the time being in force under the income-tax act and or any stationery modifications thereof. The following shall be deemed to be the principal objectives of the trust:

- i. To organize Maa Durga Puja Celebrations annually along with cultural functions.
- ii. Sree Sree Sikder Pukur Smashan Kali Mandir And Durgapuja Welfare Trust, will be able to do all repairing, construct and maintenance works of Maa Durga Temples.
- iii. To arrange preservation and proper maintenance of the Maa Durga Temple, Ashram, Mandir and others temples etc.
- iv. To acquire, hold and manage funds and properties (movable and immovable) for and on behalf of Sree Sree Sikder Pukur Smashan Kali Mandir And Durgapuja Welfare Trust.
- v. To contribute to the cause of religious duties by performing pujas for the family deity Sree Sree Sikder Pukur Smashan Kali Mandir And Durgapuja Welfare Trust, throughout the Year.
- vi. To organize any other religious puja like Laxmi, Kali & Saraswati Puja and any such puja on festival days.
- vii. To organize cultural programs and events involving various Indian traditional and contemporary cultural activities.
- viii. To organize efforts to maintain and perpetuate Indian culture among the youth.
- ix. To provide food & clothing, to promote women welfare/ health programs.
- x. To promote, assist, and/or maintain all activities by whomsoever carried on or wherever carried on in India in conformity with the objects of the Trust and are conducive to the wellbeing and general welfare of the nature are conducive for advancement of any object or objects of General Public, utility not involving/carrying on any activity for profit.
- xi. To engage, support and maintain charitable work in the field of education to eradicate illiteracy by providing / supporting basic education, health care to empower the socially and economically weaker section of society.

- xii. To support the physically or mentally challenged persons and to provide them assistance in their education, food, clothing and other necessary help.
- xiii. To grant relief and assistance to the needy / sick persons and to distribute relief material, medicines, food, water etc. in the places affected from natural calamity like flood, drought, famine and war etc. either independently or jointly with any Government or Semi-Government agencies or Association of similar object, out of its own funds or collected from outside by way of donation, grants, or contribution etc.
- xiv. To engage in the activities for the welfare and up-liftmen of women particularly widows, old aged and those belonging to lower strata of society.
- xv. To take up effective but reasonable and lawful steps for the eradication of social evils such as Dowry System, Wastage of money in various function, use of intoxicating drugs, Child Marriage (Bal Vivah ) and Child Labour etc.
- xvi. To arrange and manage marriage programs for needy and poor girls/women.
- xvii. To arrange and manage the training programme in Fine Arts, Crafts, Music, Painting, Yoga, Physical Education for the benefit of general public. To promote / preserve Indian culture, Traditions, Arts, Crafts etc and popularizing the same. Also to carry on the activities of arranging concerts, exhibitions and shooting cinematography films for the furtherance
- xviii. To provide and arrange entertainment, sports and other programs/activities for the benefit of students & general public.
- xix. To establish, develop, run, support, maintain, take-over, construct, alter, improve, manage and control of Religious Precincts, Old-age Home, yoga and Meditation Centre, Naturopathy Center, Orphanage Home, Ashram, Dharamshala, Shelters, Community Centers for the benefit and use of the general public.
- xx. To print, publish and exhibit films, journals, magazines, periodicals, books, papers, newspapers, pamphlets and advertisements, reports lectures and other reading materials and pictorial matters for the diffusion of useful knowledge and all other mass, contact programme like audio and audio-visuals, video cassettes or CDs etc for spreading of social and religious values as per the aim and objective of the Trust.
- xxi. To organize Blood Donation Camp and to run ambulance services for service to mankind.
- xxii. To educate people on HIV/AIDS and other such deadly diseases and arrange for awareness campaign for its prevention.
- xxiii. To acquire and take over all or any part of movable or immovable properties of any similar Trust, society or institution or anyone else whosoever may be for the purpose of the Trust and to maintain such assets.
- xxiv. To receive/raise funds, through grants, aid, donations, subscriptions, sponsorship, presents, rent, gifts and loans or assistance in any other form for the fulfillment of aims & objectives of the Trust.
- xxv. To undertake the conduct of regional, national, exhibition, seminars, conferences, workshops on rural development and economy.
- xxvi. To receive financial and non-financial assistance from any Government, Government and Non-Government organizations, Banks and other legal entities or individuals, as permitted by rules of the Government of India.

- xxvii. To manage, purchase and deal with movable and immovable properties of the Trust keeping in the interest of aims and objects of the Trust.
- xxviii. To invest funds and help investment of any funds in the modes of investments from time to time which is in terms of Income Tax Act, 1961 or any other law for the time being in force and subsequent amendments thereof from time to time.
- xxix. All the activities of the Trust shall be non-profitable and shall be conducted on "No Profit - No loss basis".
- xxx. To establish, maintain, support and grant aid to Maa Durga Mandir, Ashram, Temple, Haribasari, libraries, reading rooms and Harinum samkirtan teaching centre etc.
- xxxi. To arrange or organize Maa Durga Puja, Maa Lakshmi Puja, Maa Kali Puja, Saraswati Puja, Lord Krishna Puja, Maa Ganga Puja, Mahaprabhu puja, Harinam Sangkirtan, Shib puja, Rass yatra, Dolyatra and other pujas Celebrations annually along with cultural functions.
- xxxii. The committee shall be empowered to take necessary decisions, as or when required, to contribute for the performance of Maa Durga Puja, Maa Lakshmi Puja, Maa Kali Puja, Lord Krishna Puja, Maa Ganga Puja, Radhakanta Puja, Dolyatra, Goshtha, Niler Puja, Shivratri, Durga Puja and other Pujas.
- xxxiii. To educate the greater human society in the techniques of spiritual life as the basis for a balanced psychic and biological development, and thereby achieve for the first time in human society a real peace and unity among the contending forces in the world today.
- xxxiv. To propagate the sense of Godhead, the all attractive personality of primal and eternal form, as he himself revealed in his own words in the Bhagabat Gita, the holy scripture of the Lord Sri Krishna, the Godhead.
- xxxv. To consolidate, strengthen and make invincible the global Hindu fraternity by following the eternal and universal life values based on sanatan dharma and work for total welfare of humanity on the basis of the unique cultural ethos Bharatvarsha.
- xxxvi. To protect, develop and spread the Hindu values of social, ethical and spiritual life, which have sprung up in Bharatvarsha.
- xxxvii. To uphold and protect the symbols of national veneration, such as, sanctity of womanhood, cow and progeny, sacred religious places, rivers and environment concerns.
- xxxviii. To keep close relation among the members of the organization for the welfare & to take up and handle the problems of the members to try to solve such problems through discussion and to established good relation between the members of the organization.
- xxxix. To improve the welfare of the member and to promote unity, harmony and self discipline among the members through the bonds of friendship.
- xi. To create, organize and manage these fund/s as may be required according to the exigency or circumstances in attainment of the aforesaid objectives.
- xii. To contribute for the cause of education, sports and cultural activities of the locality.

- xiii. To grant axis for the establishment and maintenance of tube wells and water works for supply of drinking water and for the construction of and/or repair to tube wells and wells for the use of public in general.
- xiii. To help and grant aid to the poor and destitute people, orphans and widows, tribal, OBC, and deprived people.
- xiv. To accept funds in the form of gift, grant, donation, subscription, Govt. of India, State Govt. Societies NGOs, Govt. undertaking Bodies Institutions, Missions & Missionaries and the people of all castes and creeds.
- xv. To spread Sports and Games facilities by providing and engaging Sports goods and Trainers of various Sports events among the Mahilas, Children, Youths, Students and Aged.
- xvi. To set up Sishu Unnayan Kendra for providing facilities of Education Games & Sports, Toy libraries etc. to the tiny tots of Rural and Semi urban areas.
- xvii. To cultivate the spirit of culture among the members of the society by holding drama, dance-drama, Jatra, Film - shows etc.
- xlvi. To organize the physical culture, indoor and outdoor games competitions and sport and other type of amusement;
- xlix. To maintain public libraries, free-reading rooms for the study of Indian culture;
  - i. To observe the birth day of the great men of the country. Independence day, Republic Day, New Year Day etc. in order to uplift the morality of the people of the locality.
  - ii. To open charitable dispensary centre, free or lowest treatment centre, children and mother health care unit and also organized blood donation camp, Thalamesia etc awareness camp.
  - iii. To promote, establish, start, maintain, organize, run, manage, supervise, superintendent, co-ordinance, control, guide and grant aid to the, Dance centre, Kinder Garten School, nursery school, High School, drawing training, Sangeet training, Computer training, yoga training, karate training, Spoken English, Coaching centre, work education, libraries, auditorium, and other educational institutions for the promotion of the arts, literatures, science and commerce;
  - liii. To accept any gift, grant, donation, subscription or free towards raising any fund for the purpose of the society.
  - liiv. To render relief to the suffering in times of famine, flood, drought, earthquake and other natural calamities.
  - liv. To establish, maintain or grant aid for the establishment and/or maintenance of parks, Gardens, gymnasiums, sports clubs any kind of Sports Activities, Dharamsala and rest houses, for use by public in general.
  - lvi. To grant aid or render assistance to other public charitable trusts or institutions.
  - lvii. To help physically handicapped, aged, sick, helpless and backward and indigent person.
  - lviii. To bring, publish, print distribute and sale of News Papers, books, periodicals, leaflets, brochures and also to open and maintain Libraries, reading rooms for the promotion of the objects of the Trusts.

- lix. To contribute donations to Government for financial aids in case of any Natural Calamities, exigency of the country etc.
- lx. To accept donation, grants, presents, deposits from members and non members; both secured and unsecured fund from any Bank (s), Financial institution (s), any company, Firm, Trusts, and/or any individuals, subscriptions and other offerings and to deal with the same for the purposes of fulfilling the objects of the Trust.
- lxi. To perform work on progress of knowledge for rural people and to establish and maintain libraries, reading rooms, adult literacy classes, for educational technical, agricultural or medical knowledge:
- lxii. To raise fund by way of donations, fees etc. from any person/s, the state or central Government Organizations, companies corporate agencies, institutions or otherwise for the TRUST and/or to provide funds to such beneficiaries as many be identified by the TRUST: All donation any person or any organization by way of valid instrument and must be attached as per proper legal norms and valid document and receipts.
- lxiii. **This place shall be used for corresponding address only and shall not be treated and used as Trust Property.**
- lxiv. **This Trust shall be commenced on and from 24/03/2025**
- lxv. **The Settlor and Trustee not the owner of the Trust property they are only custodian of the property they cannot claim any property as his/their own property**
- lxvi. **The trust shall never borrow and/or augment money from the public or open market by announcing attractive financial investment scheme.**
- lxvii. **All aims /objects/purpose of the trust herein stated above shall come into effect/force after necessary appointment of the competent govt. authority in the case where affiliation / permission/license/ sanction is required.**
- lxviii. **The trust will never acts like Micro financing, micro credit, franchise and Money Laundering (act-2012) Economic offence/crime and in nature and shall not obtain any donation or like that from abroad without getting the permission of FCRA ACT from the central Govt./the competent Govt. authority which the Trust and the trustees are responsible for and the whole trust is void. And come under the all punishable laws.**
- lxix. **The Trust will never acts which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country for which the trust and the trustees are responsible for that and the whole trust is void. and come under the all punishable law.**
- lxx. **Lawful purpose:- A Trust may be created for any lawful purpose. The purpose of a Trust is lawful unless it is (a) forbidden by law, or (b) is of such a nature that, if permitted, it would defeat the provisions of any law, or (c) is fraudulent, or (d) involves or implies injury to the person or property of another or (e)the Court regards it as immoral or opposed to public policy. Every Trust of which the purpose is unlawful is void. And where a Trust is created for two purposes, or which one is lawful and the other unlawful, and the two purposes cannot be separated, the whole Trust is void.**

**BENEFICIARIES OF THE TRUST:**

The Trust is established for the Educational, Health & Welfare opportunities to Citizens of India and the class of people mentioned above without discrimination of caste, religion, race/creed or sex.

**REMUNERATIONS:**

The trustees are all forming the instant Trust as a obligation to wards the society at large and for such upright action will augment the joy and happiness amongst the trustees and they will not be remunerated personally for their attachment with the Trust remuneration clause will attract the Income -Tax Act of India.

6. To perform that notwithstanding herein contained in the income as the corpus OF THE TRUST fund the same shall be applicable and applied to for PUBLIC CHARITABLE PURPOSE ONLY within such territories and subject to such conditions or limitation if any as may from time to time be laid down by the Income Tax Act, 1961 or any other acts governing taxation of income the wealth of PUBLIC CHARITABLE TRUST so as to render the TRUST hereby established as well as its income eligible for exemption from taxation under such Act or acts, now or prevailing or any modification replacement thereof.
7. To act in such a way that the TRUST hereby established shall always retain the status of one such TRUST to which provisions of section 80G/ 12A/ 35AC/FCRA 10(23C) IV/V/VIA of the Income Tax Act, 1961 or any modification replacement or thereof for the time being in force shall apply so that any donation or contribution thereto is recognized as eligible for exemption or relief from tax in the hands of the donor.
8. **ADMINISTRATION:-** The properties and funds shall vest in the name of Trustees constituted by persons executing the Deed of the Trust. The number of members of Board of Trustees shall not exceed 15 and the vacancies can be filled by co-option by the existing Trustees.
9. **OFFICE BEARERS:-**  
Office bearers of the trust shall be initially as follows: -

The Board of Trustees is also Empowered to created any office bearer post and elect office bearers to fill up the post form the Trustees and/or from outside the Board of Trustees. The above office-bearers shall be elected by the co-option of the Trustee at a meeting convened for the purpose.

**10. VACANCIES:-**

A vacancy shall arise among the Trustees in the following cases-

- i. When a Trustee dies.
- ii. When he resigns his office as a Trustee.
- iii. If he becomes Bankrupt.
- iv. If he becomes in sane or otherwise become incapable to act or.
- v. When he is absent from three consecutive meeting of the Board, unless the Board records condoning such absence in the minutes of the meetings of the Board of Trustees for substantial cause.

- vi. When it becomes insolvent.
- vii. When convicted of any criminal offence involving moral Turpitude.
- viii. When he acts or does anything detrimental to the interest of the Trust.
- ix. On medical evidence when he is declared physically or mentally unfit by a resolution of the Board at a meeting convened for the purpose.

### **11. FUNCTIONS OF THE OFFICE BEARERS:**

#### **A) PRESIDENT:-**

- i. The president is empowered to take decisions on urgent matters, but such be approved by the Board within a period of 30 days.
- ii. The President will preside over the meeting of the Trust and conduct the proceedings.
- iii. The president in his own decision or by the request of the 3/4 of existing members can call for the meeting of the Trustees.
- iv. The President is empowered to delegate such powers to any other members of the Trust as he may deem fit.
- v. The President is empowered to dissolve the committee or the Board in any abnormal situation.

#### **11. (B) SECRETARY:-**

The Secretary who will act as managing trustee of the Board of Trust, elected under the control and supervision of the Board, shall conduct and manage all the affairs of the Trust, its all properties and institutions, sign papers and carry on the despondence on behalf of the Trust, and shall be responsible for the safe custody of records of the Trust, and keeping of the proper accounts thereof. He shall also perform such other duties as may be entrusted to him from time to time. The President, The Secretary shall attend to the correspondence and today affairs of the Trust. The Secretary shall carry out all the resolution of the Trust and for that purpose he shall have power to incur necessary expenditure form and out of the funds of the Trust, subject to a maximum of Rs. 50,000/- (Rupees Fifty Thousand) only and anything in excess of Rs. 1,00,000/- (Rupees One Lakh) only is to be incurred with the sanction of the Board. He shall have the custody of the correspondence and other books relating to the affairs of the Trust.

#### **11.(C). TREASURER:-**

The Treasurer shall conduct and receive all sorts of subscriptions, donations and deposit or money and grant receipts of money thereof. He will maintain and keep cash book and such other books of accounts as are necessary.

12. The Board of Trustees may, by a unanimous vote of all the Trustees for the time being except the Trustee proposed to be removed, remove any Trustee, permanent or otherwise, from office after finding the Trustee proposed to be removed guilty of serious misconduct in relation to or covering the trust estate or trust estate or trust affairs and after arriving at definite conclusion that for the reasons to be recorded in within the continuance of the Trustee proposed to be removed as Trustee or these presents was desirable keeping to the object of the trust in view other related or connected matters provided however that on conclusion of such shall be arrived at without giving to the Trustee proposed to be removed a full and fair opportunity of explaining his

conduct and/or the charges leveled against him for his removal and the decision of the Board of Trustees in this behalf shall final and binding and shall not be called in question anywhere.

13. **APPOINTMENT OF THEIR EMPLOYEES.**

They shall have also power employ necessary staff for management, administration and running of the Trust in general and of institution in particular on such reasonable salaries and remunerations and on such terms as may appear proper, to the Trustees for managing the affairs of the Trust and the Institutions and for the purpose of achieving of the objects of the Trust. They may be allotted or entrusted with such duties and responsibilities.

**13. (a) BANK ACCOUNT: (i)** The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of **SREE SREE SIKDER PUKUR SMASHAN KALI MANDIR AND DURGAPUJA WELFARE TRUST** such accounts shall be jointly operated by the president/secretary/ Treasurer or as shall be decided mutually in meeting of the **TRUSTEE BOARD.**

(ii) The Trust may open Bank Account/s in the name of institution/organization founded by the Trust.

14. **THAT** the **TRUSTEES** may engage themselves and carry on any business for and on behalf of the **TRUST** established by this Deed and may invest any part of funds or assets of the **TRUST** fund in such business or Businesses for the benefit of the beneficiaries and in such case individually that **TRUSTEE** shall remain responsible for his wrong and loss and for this the **TRUST MANAGING TRUSTEE** and the **SETTLER** shall remain indemnified:

15. **THAT** the **TRUSTEES** shall maintain the true and fair account of the **TRUST FUNDS**, receipts and disposed of or spent and all matters in course of management of this **TRUST**, in respect thereof or in relation to the carrying out of the object and effects to the **TRUST PROPERTY.** The accounting year of the **TRUST** shall be accounted for i.e. from 1<sup>st</sup> April to 31<sup>st</sup> March, of each English calendar year:

16. **THAT** the number of **TRUSTEES** shall be not less than 6 and not more than 15. If there shall be any vacancies of the office of the **TRUSTEES** the same shall be filled up by the continuing remaining **TRUSTEE** or **TRUSTEES** by the process nomination in consultation with and acceptance of the **SETTLER.**

17. **THAT** the **TRUSTEES** shall have the full power to compromise or to compound all actions against such suits and settle all accounts relating to the **TRUST PROPERTY** and to do all suits and settle all accounts relating as fully and effectually as if they were absolutely entitled to the **TRUST PROPERTY** without being liable or answerable for any loss thereby.

18. **THAT** the receipt of the **TRUST** for any money, stocks, funds, shares, securities or investments paid delivered or transferred to them in execution of the **TRUST** or power hereof shall effectually be released and discharged the persons paying delivering or transferring the same.

19. **THAT** the **TRUSTEES** jointly shall be responsible for such money, stocks, shares, funds and securities as they actually receive notwithstanding their respectively signing a receipt jointly with other for the sake of conformity and shall be answerable and accountable for the account, receipts neglects and any banker, broker or other person or persons with whom or whose hands any **TRUST** moneys or securities may come or be deposited or given or for insufficiency or deficiency of any stocks, shares, funds or other securities nor for any other loss unless the same shall happen through their default or negligence respectively:
20. **THAT** the **TRUSTEES** shall reimburse and pay and discharge out of the **TRUST FUND** all expenses incurred in course of the execution and administration of the **TRUSTEES** and in uses or for carrying out their duties these presents but they shall not be entitled to any honorarium or salary for the **TRUST**:
21. **THAT** in case of difference of opinion among the **TRUSTEES** decision of the majority **TRUSTEE** as the case may be shall prevail and by every three months meeting of the **BOARD OF TRUSTEE** shall be held and evolution of the works of each member of the **BOARD OF TRUSTEE** shall be made in the annual meeting of the **BOARD** and in that meeting ineffective member of the **BOARD** shall be expelled in proper system:
22. **THAT** any **TRUSTEE** may delegate in writing all or any of his or her powers under these presents to his or her **CO-TRUSTEE** as nominee who will be entitled to exercise such power or powers. In the same manner as the **TRUSTEE** himself could do personally notwithstanding anything herein contained the **TRUSTEE** shall be entitled to use the name of the **TRUST** in connection with any matter relating to the said **TRUST** and for the purposes the said **MANAGING TRUSTEE** for the **TRUST** shall appoint, dismiss and reappoint any staff, manager, lawyer, adviser, advocate, auditor and substitutes and pay their expenses and fees as shall be deemed reasonable from time to time and for the purposes of the said matters and actions in Courts or otherwise the **TRUSTEES** or any of them or the **MANAGING TRUSTEE** shall be entitled to sign and verify all plaints, petitions, pleadings, written statements memorandums, Vakalatnamas powers the **TRUSTEES** or any of them shall be entitled to appear for and on behalf of the **TRUST** and give evidence orally or adduce any evidence and take necessary proceedings on the matters and actions:
23. **THAT** any of the **TRUSTEES** may retire from trusteeship if he or she so desires, but with acceptable reasons:
24. **THAT** the power to appoint/nominate new or additional **TRUSTEES** so as not to exceed the maximum number of **TRUSTEES** existing herein and to fill vacancy in the office of the **TRUSTEE** shall vest in the continuing **TRUSTEE** or **TRUSTEES**.
25. **APPOINTMENT OF NEW TRUSTEES** It is agreed that if the Trustee sees fit he may appoint an additional Trustee to be Trustee of the Trust. Change of Trustee. It is agreed that if the Trustee becomes unable or unwilling to act as Trustee of the Trust he or his lawful representative may appoint a new Trustee to be Trustee of the Trust provided that this new trustee shall accept his appointment

26. **DELEGATION OF POWER:** The Trustee shall have the power to delegate the administration of the Trust to any third party which he in his absolute discretion shall see fit provided always that the Trustee remains responsible for the actions of any party to whom he has delegated authority.
27. **THAT** on a new **TRUSTEE** being appointed/nominated on his signing the Minute Book to holding the effect of his possession of the **TRUST PROPERTIES** shall vest in him along with the other **TRUSTEES** for the time being and he will be entitled or to carry out the duties and function of a **TRUSTEE:**
28. **THAT** for amendment or change of any clause of this **TRUST DEED** the **MANAGING TRUSTEE** shall prepare it and get in accepted by the **BOARD OF TRUSTEE:** **THAT** in case members of **BOARD OF TRUSTEE** decide finally in the meeting of the **BOARD OF TRUSTEE** that they shall not continue the **TRUST** may more, they shall after clearing all the accounted liabilities fully of the **TRUST** from the proceeds of the assets of the **TRUST**, wind up **THE TRUST** legally, and shall handover all the residue assets of the **TRUST** to a similar **CHARITABLE TRUST** or The Government who will carry on all the works of this **TRUST.**

30. **IMMOVABLE PROPERTIES OF THE TRUST**  
No immovable property belongs to the Trust shall be sold, exchanged, transferred, converted, mortgaged or alienated in any manner whatsoever except when such exchange, transfer, conversion or alienation:
- i) Is imperative in the interest of the Trust and Institutions and Department connected therewith,
  - ii) Is not likely to adversely affect to any extent whatsoever the existence and benefit of the Trust, Institution and departments connected therewith an object of the Trust, and
  - iii) Is decided to that effect by the Board in its meeting by a resolution passed by majority of the Trustees present.

### 31. AMENDMENTS TO THE SCHEME

If any time it is found that alterations in any of the provision of the Trust or scheme for the purpose of effective achievement of the object of the Trust are imperative and very essential, then the Board shall approve such alteration by a resolution passed in its meeting and thereafter the modification shall become part and parcel of the terms, condition and provisions of this Trust and of this scheme.

The Board may at any time and from time to time make, amend, delete and rescind rules and bylaws for the conduct of this business, for the control, management and administration of the Trust made under this Trust deed and for carrying out the objects of the Trust relating to any matter under this scheme, provided that such rules and bylaws shall not be inconsistent with or repugnant to any provisions of the scheme of the Trust.

**32. INVESTMENT OF TRUST FUNDS:**

1. The Board of Trustees shall have the power to invest the funds, assets and properties of the Trust at their discretion in accordance with the provisions of the Income Tax Act, 1961. & circular of SEBI
2. The Board shall also determine from time to time, the amount it shall spend on the various activities of the Trust.

**33. INDEMNITY:**

The Board of Trustees shall be indemnified for any act done by them in good faith in the course of the administration of the Trust.

**34. APPLICABILITY OF TRUST ACT:**

The provisions of the Indian Trust Act 1882 shall apply to all matters not specifically mentioned in these presents.

**35. DISSOLUTION CLAUSE:**

In the event of dissolution of the Trust, the entire Trust funds shall be realized and first be used for payment of liabilities of the Trust. **36. AREA OF OPERATION:**

That all activities of the Trust shall be extended to the territories of India.

**37. IRREVOCABLE:** That the Trust is irrevocable.

**38. UTILISATION:**

To apply the whole or part of the income of the Trust or accumulation thereof or whole part of the corpus of the Trust Fund for one or more of the object of the Trust may determine from time to time.

**39. SAVE CUSTODY OF TRUST ESTATE:**

That all securities, investments bonds, title deeds etc. relating to the Trust estate shall be kept in the safe custody with the Trustees or Bankers(s) of the Trust.

**40. DECLARATION:**

This Trust and Scheme set forth under Indenture shall come into force immediately after the execution and registration thereof.
